US Route 199 South towards the coast, take Demaray Drive on the left, Stay straight on Demaray til you get to Midway. Left on Midway, Saddletime Farm is on the right. Sign is out front.

ENTRIES & CLOSING DATE: Your entry must be RECEIVED by March 19, 2023 To be accepted, entries must be complete, signed (by parent or legal guardian if handler is a minor), received by the closing date, and accompanied by the correct fees made payable to **RCA**. You must file a separate entry form for each dog entered (i.e., only one dog per form).

NOTICE TO EXHIBITORS

- The safety of the dogs is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely.
- Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the show committee. A refund will be given for bitches in season. A letter from your veterinarian is required by the first day of the Trial.
- All fees must be paid in US funds. There will be a Returned Check Fee of \$25.00 for returned checks.
- In the event of withdrawal from the event, checks will NOT be returned. All unused checks will be destroyed.
- It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior, may, at the discretion of the show committee, be asked to leave the show site. In that case, no refund of any fees paid will be made.
- All dogs must be on leash at all times except when using the warm-up area or in the agility ring.
- No entry fee will be refunded if the Trial cannot open or be completed by reason of riots, civil disturbance, fire, an act of God, public emergency, act of a public enemy or any other cause beyond the control of the organizing committee.
- Obstacles shall meet the specifications for obstacles in the current edition of the Regulations for Agility Trials.
- Exhibitors are responsible for complete, accurate and legible information on entry forms; illegible or incomplete entries cannot be entered in the Trial.
- Exhibitors must clean up after their dogs at the hotel and at the Trial Site.
- Exhibitors are responsible for being at the ring gate when it is their turn to run. Exhibitors may wear shirts or insignias of their training group, if they wish.
- Choke collars, pinch collars, electric and dummy electric collars are PROHIBITED.

RULES REGARDING USE OF FOOD AND TOYS IN THE RING The handler shall be allowed to carry and use food treats and toys in the ring as reward for the dog so long as they are not offered in a way that assists the dog in course direction or in the performance of an obstacle. The dog receives 20 faults (failure to perform) when the handler uses a food treat or toy in a manner that assists the dog in course direction or in the performance of an obstacle. A food treat must be kept secure by the handler. The dog shall earn 20 faults if the handler carries food in hand while the dog is working or at any time drops a food treat on the floor or equipment. Questions regarding this rule change will be addressed during the General Briefing each day of the trial.

Obstacle Familiarization - obstacle familiarization will be held Saturday and Sunday morning 30 minutes prior to judging for dogs.

Warm-ups - a warm-up area, consisting of a regulation agility jump, shall be provided for all Exhibitors.

Show site – the trial will be held at Saddletime Farm in Grants Pass, Oregon

Eligibility - this trial is open to all dogs **20 inches** and under at the withers that are over the age of 12 months, except bitches in season, aggressive dogs, or dogs suffering from any deformity, injury or illness which may affect a dog's physical or mental performance.

Move-Ups - Move-ups will be accepted for dogs earning a title at a prior show up to the closing date. Move-up requests must be in writing but may be sent via e-mail. Move-ups will also be accepted if a dog completes a title during the running of this trial. In such case, the Move-Up request must be made immediately upon posting of scores for the

class in which the title was earned. "Move-up Request Form" is set out later in premium and available on the Secretary's Table at show.

AWARDS: Ribbons will be awarded for 1st through 4th in each jump height of each class. Qualifying ribbons will be awarded to all dogs receiving a Qualifying Score. FEO (For Exhibition Only) will be offered.

Judging Times: Judging will start at **9:00 a.m. each day.** Site will be open at 7:30 a.m.

The following is a list of obstacles to be used: (All TDAA size):

A-frame (6'8" sides w/slats)	Weave Poles (20" centers)
Table (30" sides)	
Winged Jumps	Tire Jump (18" loop)
Open (pipe) Tunnel (16" loop)	Dog Walk (8' planks w/o slats)
Teeter (8' plank) (w/out slats)	Jumps without wings

CLASS INFORMATION

Games Classes

Games I - All dogs shall be eligible for participation in this class. There shall be no grand-fathering of titles from other organizations.

Games II - Only dogs who have earned the Games I (TG1) shall be eligible for participation in this class.

Games III - Only dogs who have earned the Games II (TG2) or Games III (TG3) shall be eligible for participation in this class.

Jumpers: Jumpers is a numbered course. Follow the numbers and keep the bars up. Faults then time- ER12

Time 2 Beat: A numbered course with one or two contacts. Top performing dogs set the Q criteria for each jump height -ER6

April Fools – A standard course where the handler turns their back before they run and 2 obstacles are removed.

Four Leaf Clover – is a distance game usually shaped in a clover format with a stem.

JUMP HEIGHTS

Owners are responsible for entering the proper height division. Judges reserve the right to measure dogs entered in any trial. At the handler's option, they can have their dog jump at any height they choose. Dogs jumping at a height other than their measured jump height will earn all TDAA qualifying runs and titles.

- 4" for dogs 8" or less at the withers, or dogs with a jump height exemption measuring 12" or less
- 8" for dogs 12" or less at the withers, or dogs with a jump height exemption of 16" or less.
- 12" for dogs 16" or less at the withers, or dogs with a jump height exemption of 20" or less
- 16" for dogs 20" or less at the withers.

ALL DOGS WILL PLACE WITH DOGS IN THE HEIGHT CLASS IN WHICH THEY MEASURE AT THE WITHERS.

ALL DOGS WITHOUT A PERMANENT HEIGHT CERTIFICATE MUST BE MEASURED PRIOR TO THE FIRST DAY OF COMPETING AT THIS TRIAL. ARRIVE EARLY ENOUGH TO ACCOMMODATE MEASURING.

Disabled Handlers: A time exemption will be granted to disabled handlers amounting to 4 seconds in Standard course times and in qualifying course times for Games classes. Proof of disability shall be a copy of the handler's disability parking tag or other official documentation, which must be included with the entry or presented at check-in at the trial.

Entries

Entries close March 19, 2023, after which time entries cannot be accepted, canceled, altered or substituted. Day of Event Entries **WILL BE** accepted **up and until 8:15 a.m** each morning, for additional \$2.00 per run. TDAA Dog Registration Numbers may be applied for at the event so that your dog can participate in this trial.

Entries will not be accepted without fees. Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the Trial Committee. No entries will be accepted which require a signature for delivery. All entries must be submitted on official TDAA Agility Entry forms. One dog per entry form.

Photocopied entries, without the signed TDAA Agreement attached are NOT acceptable. Unsigned, incomplete or illegible entries are NOT acceptable and cannot be entered in the Trial. Faxed entries and/or credit cards cannot be accepted. Returned checks do not constitute a valid entry fee. The Trial Secretary will add a \$25.00 service charge for any returned check(s). Subsequent returned check(s) from the same Exhibitor may result in their being put on a CASH ONLY basis.
